We will have 8.146 in reserves if everything is spent down completely.	
Day Reporting Centers Summer Camp Presentation – PO: Darrin Jefferson – Victorville PCO: William Burnett Jr. San Bernardino YJC	Ms. Smith-Lacy- We have three Day Reporting Centers in our county under JJCPA. They are located in Victorville, San Bernardino and Montclair. Montclair is presently in Summer Camp so a representative is not available. Probation Corrections Officer William Burnette Jr. and Probation Officer Darrin Jefferson, are here to do a presentation on the programs and activities provided at our Day Reporting Centers Summer Camp. Mr. Burnett Jr our mission was to take kids from the community and expose them to activities they are not used to, or have never been able to experience. Building appropriate relationships with one another and seeing law enforcement in a different light. It was a five week program for ages 12 – 17. We had 20 youth in each

Ms. Fortuna provided a presentation for the committee on the Parent Engagement Program. Highlighting its objectives, goals and successes.	
Fortuna	Ms. Fortuna- The goal of the program is to address truancy. With the help of parents, schools and a collaboration with community members and organizations, which include: Probation, the SARB Board team, counseling services and the Public Defender's Office. We work with parents and their ability to effectively communicate with the children to meet their physical, emotional, and social needs. We go to their school and home to assess what may be needed. There are several programs available to help with specific assistance. Video presented and narrated by Ms. Fortuna. We have received recognition for statewide model SARB's by the San Bernardino County Superintendent of Schools. We have also received letters of thanks from our clients in appreciation for services provided. Ms. Irwin- Attendance, and their progress, is also followed and tracked. Yucaipa/Calimesa: 67 total kids have been discussed at SARB meeting's this year; 137 students are currently active in LET data base

Redlands Joint Unified: 9 kids total have been discussed at SARB (They just got a new SARB chair at the end of the school year, Robin Gonzales got new assignment and was doing double duty until April). We have 36 kids are in our data base.
