V. Public Defender Proposal Revision	The Public Defender's Office had a proposal for youth scholarships that they provide to youth in the community. They noticed that one line in their proposal was too hard to meet. They have youth with behavioral and/or mental health diagnosis, but most youth don't have a diagnosis. To better serve the youth, they want to modify it to behavioral or mental health issues or parental incarceration. They had and parental incarceration, so it read as if they needed to meet all of the criteria. All you need is one qualifying risk factor for a youth. The way it reads is that these risk factors include victims of physical, sexual, or emotional abuse, neglect, homelessness, changes of behavioral or mental health issues, or parental incarceration, and that way they can easily comply with their proposal. VII. PD LET Updates	During this quarter, the L.E.T. Social Service Practitioners extended one-on-one services to 21 new students and their families. The SSPs attended 10 Student Attendance Review Board (S.A.R.B.) meetings across three districts (Fontana Unified School District, Yucaipa-Calimesa Joint Unified School District, and Snowline Joint Unified School District). Parent Engagement: SSP Bates has continued conducting Parent Engagement workshops throughout the Fontana Unified School District. He will also begin conducting workshops at the Family Learning Center in Yucaipa-Calimesa Joint Unified School District. Additionally, SSP Bates was honored at the 26th Annual Shine A Light on Child Abuse Prevention Awards ceremony for his continual work with truancy and Parent Engagement. Upcoming Parent Engagement: April 2025 Kaiser High School in Fontana Yucaipa-Calimesa Joint Unified School District's Family Learning Center Success Stories: Our SSP's reported: Three Seniors are now on track to graduate. Through frequent check-ins and ongoing encouragement, these individual students will be graduating with their class. A 17-year-old student was able to successfully transfer back to their home school site after attending a continuation school. This student was almost a full academic year behind in credits. This student put in the work. They completed summer school classes, engaged with their school counselor and teachers, and are now on track to graduate from their home school. A recent graduate, who has faced housing instability for several years, completed their first semester at community college with straight A's. They managed to do this while also working part-time at two different jobs to support their mother and sibling with rent and groceries.	R. Sterling

	Vacancies ■ During the last reporting period, the Public Defender's Office was able to fill three vacant positions. Two employees have started their JJCC-funded positions. One additional employee is scheduled to begin at the end of May.		
VIII. DA LET Updates	Ann Marie Pierce has met with the families of approximately 200 students (Colton/Rialto/West End) since the last quarterly meeting. She has been seeing issues related to student/parent apathy, lack of reliable transportation, stable housing, and unreported or untreated medical issues. She has referred several students to the Probation Department for tutoring and other classes. They were recommended parenting classes though various community/private agencies. Chaffey Joint High School has sent approximately 1400 referrals for the LET database. It is a substantial increase for that district from the previous quarter. They will be reaching out to the Principal to see if there is anything they can do to assist the students and their families. She presented items at a career fair. She will be distributing incentive gift cards to students who were on a SARB contract and improved their attendance during the school year.	J. Gregory	
	Heny Rosas attended 17 SARB panel meetings and met with approximately 115 families of students. The most common barrier to attendance is mental health and emotional issues that the students are struggling with. He referred many students to school counseling and outside counseling. He distributed three alarm clocks to students who lacked their own alarm clock and showed improvement in their attendance. Mr. Rosas distributed seven gift cards (Subway and Starbucks) to students who have significantly improved their attendance. He attended and presented several career days throughout the county. He taught the Civil Liberties class at their local high school. He continues to participate in the San Bernardino Safety and Attendance Committee. He taught a truancy class with the Fontana FLIP program. Mr. Rosas conducted school site home visits to follow up with students who are struggling with attendance.		
	In attention to Jennifer Roth's SARB meetings, she worked with the Sheriff's Department in Barstow to have deputies attend future SARB meetings in Yermo, Baker, and Trona. Deputies will have up to date information regarding student attendance and will be serving citations to parents when necessary. DDA Roth is working with the Fort Irwin Army Liaison regarding military parents who are not sending their children to school. DDA Roth is working with the SRO leadership at the Sheriff's Department to update processes for serving citations to parents who are in violation of SARB contracts. Silver Valley Unified School District has implemented a parenting class that is free to SARB parents.
