IV. Chief's Updates	Juvenile M.A.P. attended the meeting to present what they do for youth in the community. M.A.P. manages treatment, rehabilitation, and education using local community resource partnerships. They offer non-residential day programs with San Bernardino County and partner facilities to provide enhanced treatment, rehabilitative services, and vocational programs. M.A.P. offers wrap-around services. They offer youth community services linkages, independent living skills programs, parenting skills, and family preservation activities. Shaunte Bowman is the Program Director. Maisha Johnson is the Administrative Assistant. Darnell Johnson is the QA Subcontractor Coordinator and Chloe Llamas is the Case Manager. M.A.P. collaborates with Community Based Organizations such as Highlanders Boxing, Metztli Counseling, Operation New Hope, Simple Solutions, IE Rebound, Young Visionaries, CHORDS Academy, All Smilez Loving Care, and The Good Part Perspective. M.A.P works closely with the School POs by giving incentives to students and helping with memorable events like prom and graduation. M.A.P. helped Probation's Juvenile Day Reporting Center with Summer Camp. They had youth from Central, High Desert and West End participate. M.A.P. participates in County and Community events	Y.
